Oregon CEO Pay Ratios 2018 & 2017

Greenbrier's 643 to 1 Highest So Far in 2018 – In the second year of public company disclosures about CEO pay ratios and median employee salaries, Greenbrier Inc (NYSE: GBX) had the highest CEO pay ratio of a Oregon company for 2018 as of March 31, 2019. Put another way, it would take an average Greenbrier employee 643 years to earn the 2018 salary of CEO William Furman. Or since Mr. Furman made \$3,600/hour, he would have earned his employees' median annual pay in less than 3.5 hours.

Flir System's 142 to 1 Highest in 2017 – The highest CEO pay ratio for a Oregon company in 2017 belongs to Flir Systems at 142 to 1. In other words, it would have taken an average Flir employee 142 years to earn the 2017 salary of its CEO James Cannon. Or since Mr. Cannon made \$5,400/hour, he would have earned his employees' median pay in two days.

197 – The average Oregon CEO pay ratio in 2018, as of March 31, 2019, was 197 and 2017 was 197.

Oregon's Average Pay Ratio Not the Highest – In comparison to an average 2018 S&P 500 pay ratio of 272, Oregon's 2018 average of 197 appears to be relatively more equitable.





Methodology:

MyLogIQ reviewed the publicly traded Oregon companies that have disclosed CEO pay ratios in their 2019 annual proxy reports filed with the SEC through March 31, 2019 and in their 2018 annual proxy reports filed with the SEC. This report is the first cut on 2019 proxy filings. The majority of proxies for 2019 will be filed by the end of June. We will issue another report in July 2019.

The CEO pay ratios disclosed in annual proxy reports are for the prior year. The internal pay ratio compares a CEO's total compensation with that company's median employee salary. This is the second year that publicly traded US companies have been mandated to disclose their pay ratios.
